The Cuban Club Foundation, Inc. is a 501 (c) (3) non-profit dedicated to the restoration and preservation of the Cuban Club Building and the promotion of its use by the community. The Circulo Cubano's charter expressed the hope. "To bind all Cuban residents of Tampa into a fraternal group, to offer assistance and help the sick." While the club no longer exists for its original purpose, the building tells the story of the unique immigrant experience. The Foundation uses the building as an events and performing arts center to raise money for preservation activities. The building is open for tours where its history is retold.
